

**ORDINANCE 2014-01**  
**CITY OF HIGHLAND, ARKANSAS**

**AN ORDINANCE TO ESTABLISH A TOBACCO-FREE CITY PARK POLICY;  
TO SET PENALTIES FOR VIOLATION OF THIS ORDINANCE; AND FOR  
OTHER PURPOSES**

**WHEREAS**, the City of Highland, Arkansas, provides city park or parks for the use and enjoyment of its residents and visitors; and

**WHEREAS**, the City Council of the City of Highland, Arkansas, has determined, based on the scientific evidence provided, that the use of tobacco products in the presence of children has deleterious effects on such children; and

**WHEREAS**, the City of Highland, Arkansas, desires to provide a healthy and safe environment for the users of the city park or parks

**NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE  
CITY OF HIGHLAND, SHARP COUNTY, ARKANSAS, THAT:**

**SECTION 1.** The City of Highland, Arkansas, adopts a policy forbidding the use of tobacco products in its City Park or parks.

**SECTION 2.** Tobacco products include any substance containing tobacco leaf, including but not limited to cigarettes, cigars, pipe tobacco, hookah tobacco, snuff, chewing tobacco, dipping tobacco, snuff, or any other preparation of tobacco.

**SECTION 3.** Signs will be erected and maintained in the City Park or parks to the effect that tobacco use is prohibited therein.

**SECTION 4.** Any person who violates this ordinance by using tobacco products in the city park or parks of the City of Highland, Arkansas, shall be guilty of a violation punishable by a fine not exceeding \$50.00 (fifty dollars) per occurrence.

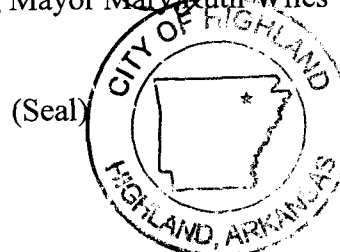
