

ORDINANCE NO. 2006-04
CITY OF HIGHLAND, ARKANSAS

AN ORDINANCE TO REQUIRE VEHICULAR TRAFFIC ON REBEL DRIVE IN THE CITY OF HIGHLAND, ARKANSAS, TO BE RESTRICTED TO ONE-WAY (WEST TO EAST) WEEKDAYS FROM 7:15 A.M. TO 8:15 A.M.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HIGHLAND, ARKANSAS:

Section 1: The City Council of the City of Highland, Arkansas, has determined that morning traffic near and adjacent to the three school campuses of the elementary, middle and high schools has become a potential danger to the safe operation of the school buses and students.

Section 2: To alleviate the recognized problems with the current traffic flow around the schools, vehicular traffic on the road known as Rebel Drive shall be permitted to proceed only one way (from west to east) from 7:15 A.M. until 8:15 A.M. on weekday mornings.

Section 3: Rebel Drive shall be marked with appropriate signs to the effect that it is restricted to one-way traffic for the period of time between 7:15 A.M. and 8:15 A.M. Monday through Friday.


Section 4: To avoid confusion and potential for accidents, Rebel Drive shall be restricted to one-way vehicular traffic every weekday mornings of the year, whether or not school is in session or the weekday is a holiday.

Section 5: This ordinance being necessary for the preservation of the public peace, health, comfort, safety and welfare of the City of Highland, Arkansas, an emergency is hereby declared to exist and this ordinance shall be in full force and effect from the date of its adoption.
