AMENDMENT TO
ORDINANCE NO 03-29

Amendment to Ordinance No. 03-29, An Ordinance establishing the procedure for making purchases of all supplies, apparatus, equipment, materials and other things required for public purposes in and for the City Of Highland, Arkansas, and to make all necessary contracts for work or labor to be done or materials to be furnished for the benefit of said City: or in carrying out any work or undertaking of a public nature: and for the payment of the same: declaring an emergency: and other purposes.


Amendment shall read:

Section 2- A: An exception to the limitation of Section 2, above, shall be noted as follows. In some instances, it is impractical for the City of Highland to advertise for bids before making a purchase because of emergency, sole source, special pricing or other conditions. The City Council of the City of Highland shall in those cases authorized the purchase of specific material, supplies, apparatus, equipment or other items and establish in the maximum price to be paid for each item to be purchased. The City Council shall place in the minutes of the City Council meeting the reason or reasons the sealed bid procedure of Section 2 is not to be followed for each item. The City can then purchase those specified items at the price below the maximum without further approval of the City Council. The City Council will be informed of the purchase at the next City Council meeting where the City Council will approve the purchase and entered into the minutes of the next Council meeting.

This amendment being necessary for the preservation of the public peace, health, safety and welfare of The City of Highland, Arkansas, an emergency is hereby declared to exist and this Amendment shall be in full force and effect from the date of its adoption.


