

ORDINANCE NO. 2007-06
CITY OF HIGHLAND, ARKANSAS

AN ORDINANCE TO REQUIRE CONNECTION TO THE HIGHLAND SEWER SYSTEM; AND DECLARING AN EMERGENCY TO EXIST.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HIGHLAND, ARKANSAS:

Section 1: Any property within 300 (three hundred) feet of the Highland Sewer System is required to connect to the Highland Sewer System.

Section 2: Violation of this ordinance shall be a misdemeanor punishable by a fine of not less than \$100.00 (one hundred dollars) for each day such violation continues, each day being considered a separate offense.


