SECTION 2: Any and all business transactions conducted with any City Official or City Employee or City Employee's relatives must have prior approval by the City Council.

<u>SECTION 3</u>: If any provision of this ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.
