The special meeting of the Planning Commission for Tuesday, August 1, 2017 was called to order at 5.30 pm by Commissioner Jayson Ozbun. The roll having been called and the following Commission Members answered to their names: Michael Burton, Kenneth Massey, Larry Allen, Jayson Ozbun and Lisa Auld. ## Consideration of June 8th & 27th, 2017 Minutes:

Commissioner Ozbun asked for approval of minutes of the June 8th & 27th, 2017 meeting. Commissioner Burton made a motion to accept the minutes of the June 8 & 27th, 2017 meeting and this was seconded by Commissioner Auld. All in favor.

#### **NEW BUSINESS**

This will all be based on final approval by the state of Arkansas. Commissioner Burton made a motion to allow First Landmark Missionary Baptist Church to go forth with their plans for the new building and this was seconded by Commissioner Massey.
