Absent was commissioner Jeff Kamps, Commissioner Roy Johnson passed away.

Consideration of August 02, 2022, Minutes:

Chairperson Massey asked for approval of the August 02, 2022, minutes. Commissioner Evans made a motion to accept the minutes as written, which was seconded by Commissioner Lindley. Minutes were passed and accepted with a voice vote.

Old Business

The General Plan was discussed in further detail, with advice from Mr. Jim von Tungeln of the Municipal League. The city must create a master street plan before further changes may be made.
